edTPA safety net amendments

Extension given for the 2020-21 and 2021-22 academic year for test takers.

Eligibility included:

- Candidates who completed a student teaching or similar clinical experience during the 2020-2021/2021-2022 academic years while enrolled in a New York State registered teacher preparation program;
- Candidates who completed a student teaching experience during the 2020-2021/2021-2022 academic years while enrolled in an acceptable out-of-state teacher preparation program; and
- Candidates who completed the teaching experience requirement for certification through the individual evaluation pathway during the 2020-2021/2021-2022 academic years.

- **Covid Emergency Certificate**

Covid Emergency Certificate issued with extensions given the pandemic.
