Introduction

The 2024 Drug Free Schools and Communities Act biennial report covers the 2022-2023 and 2023 -2024 academic years. The report is prepared to meet the requirements of the 1989 amendments to the Drug Free Schools and Communities Act as articulated in Part 86, the Drug Free Schools and Campuses Regulations.

I. Description of Alcohol and Other Drugs Program

SUNY Potsdam's Alcohol and Other Drugs (AOD) program consists of four parts (prevention and education, environmental strategies, policy development and enforcement and academic preparation). The program is administered by a diverse group of departments and offices across campus to best be able to address AOD concerns with different portions of the campus community. Examples of activities that occurred during the 2022-2023 and 2023-2024 academic years are included below:

Prevention and Education

- Narcan Training in 2023-2024, Environmental Health and Safety staff provided Narcan Training to 73 students, 17 employees, 16 community members. In 2022-2023, the Student Health Services offered Narcan training across campus.
- Public Health Day 2024 hosted by Department of Public Health and Human
 Performance the topic was harm reduction, and provided a day of education about substance use and how to reduce harm associated with that use
- Health Resources Website (<u>Health Education/Resources | SUNY Potsdam</u>) maintained by Student Health Services
- Culture of Respect Educational Campaign sponsored by Office of Title IX and Student Conduct and Community Standards, included info about bystander intervention and the campus alcohol and drug amnesty policy
- Wellness Wednesdays While classes were in session, the campus health educator tabled on Wednesdays, usually in the student union, to provide health and wellness information. Topics varied but included AOD themes regularly.

Environmental Strategies

The Office of Campus Life, Office of Residence Life, Office of Athletics, the Center for Diversity (CFD), and Student Government Association (SGA) work with students and student groups to offer programs, events, intramurals, and club sports providing students late night and weekend alternatives to parties where alcohol and drugs are prevalent. Through our Campus Life Office, Office of Residence Life and other programmatic offices and through Student Groups, SUNY Potsdam offers alcohol free programming on nights and weekends, with special attention to the first weeks of each semester when students are most likely to look for engagement opportunities.

Examples of late night and weekend programming offered during the academic years 2022-2023 and 2023-2024 include late night and weekend, alcohol free programs, weekly ice skating events, shinny hockey, open play in the Maxcy Hall Field House, camping/hiking trips and intramural activities. Off campus events like bus trips to Syracuse and Ottawa and alternative spring break in the Adirondack Park were also offered. In the academic year 2022-2023, Campus Life staff offered 28 late night or weekend programs. In the academic year 2023-2024, Campus Life staff offered 47 late night or weekend programs. A listing of the campus life programs is contained in the appendices.

Policy and Policy Enforcement

SUNY Potsdam enforces a code of conduct for employees, students and visitors that follows NY State and Federal Law. See Section IV for policies. The Office of Student Conduct and Community Standards works with staff in Residence Life and University Police to enforce student policies. The Office of Human Resources enforces employee policies. The campus alcohol policy follows the New York State Law. The campus policy allows students 21 years of age or older to consume alcohol in the residence halls. Use of alcohol in other areas of campus is governed by the campus alcohol policy which includes specific regulations for presence of alcohol at campus-wide functions.

The campus adheres to the federal regulations related to the use of cannabis. Therefore, use or possession of cannabis in any form is prohibited on the campus of SUNY Potsdam regardless of the individual's age. Educating the campus, particularly students, about the prohibition of cannabis is a priority of the Office of Residence Life and the Office of Student Conduct and Community Standards.

Students found responsible for a first-time violation for use of alcohol or cannabis are usually placed on conduct probation for a semester and required to complete an educational component and submit a reflection paper to the hearing officer. Subsequent findings of responsibility lead to stronger sanctions.

The campus also has a medical amnesty policy regarding alcohol and other drugs. The health and safety of the members of the Potsdam community are of primary importance and all students are strongly encouraged to be active bystanders who respond in potentially dangerous situations without fear of reprisal from the college. The medical amnesty policy is intended for use in isolated situations and does not excuse or protect those who flagrantly and frequently violate College policy. The purpose of the medical amnesty policy is to increase the likelihood that medical attention is provided to students who need it due to alcohol intoxication or use of drugs by removing impediments to seeking assistance. When a student assists an individual who is intoxicated or under the influence of drugs in procuring medical assistance, that student may be granted amnesty from formal action within the campus student conduct process. Similarly, a student who is intoxicated or under the influence of drugs and seeks medical attention may be granted immunity from formal action within the campus student conduct process. In these cases, the student may be required to complete an education component or alcohol or drug assessment. Six students were provided amnesty in 2022-2023 and four students in 2023-2024.

The SUNY Potsdam campus is a tobacco-free campus. Tobacco use of any kind is prohibited on campus, at extension campuses, at all indoor and outdoor events, and in all vehicles and equipment owned, leased or operated by the college. Sale of tobacco products on campus is prohibited. The college will not accept advertising, marketing, distribution, or promotion of tobacco or electronic cigarette / electronic aerosol delivery device products.

Academic Preparation

The Department of Public Health and Human Performance offers majors and minors related to public health and health education. As a part of their academic work, students and faculty of this department provide the campus health education through internships, practicums and programs.

- Curriculum PHTH 250 Drug Studies and PHTH 325 Alcohol Studies
- Internships regularly place student interns at Seaway Valley Prevention Council, where students do community-based substance use education and harm reduction programs

Other Services

<u>Student Health Services</u> provides confidential, comprehensive health care and advice to students including educating students on health risks (short and long term) of substance use and abuse. Referrals are made to community treatment agencies.

The <u>College Counseling Center</u> promotes the personal development and psychological well-being of all students by providing quality mental health services and strives to improve accessibility of mental health resources to the diverse student population and their everchanging mental health needs. The counseling center is staffed with licensed professional counselors as well as a psychiatric nurse practitioner. They provide confidential short-term counseling and address a wide variety of mental health issues via individual and group counseling sessions. Clients with substance abuse or addiction issues are referred to community agencies

The campus Clinical Case Manager through the <u>Bear CARE</u> program offers confidential comprehensive support to students who need assistance with difficult or unexpected life events during their time in college. The mission of the Bear CARE Program is to assist students with navigating and accessing vital on- and off-campus resources in order to

optimize their personal and academic success and well-being. The program is a short-term collaborative service that involves identifying areas of need, developing an action plan to address areas of need and connecting with supports and services, both on and off campus, to meet identified needs. The Bear CARE Program can provide educational resources, assist with navigating campus & community supports, make referrals to services on and off campus and provide advocacy support.

The New York State <u>Employee Assistance Program (EAP)</u> is a confidential assessment and referral service for New York State government employees and their family members who need assistance with personal problems or concerns that may be affecting their work performance or overall well-being. EAP focuses on such issues as family and relationship issues, work stress, inter-personal difficulties, substance abuse or dependency, aging parents, legal matters and financial concerns. EAP can locate resources in the community to help you begin resolving such concerns.

II. Statement of AOD Program Goals and Description of Goal Achievement

SUNY Potsdam strives to reduce misuse of alcohol and other drugs through a combination of prevention education, policy enforcement and alternative programming

A. Data from University Police

University Police compiles data by calendar rather than academic year and includes students, employees and community members. Calendar Year 2024 data not compiled at the time of this report.


The chart below indicates the number of students charged with violating the campus policies related to cannabis and alcohol. A charge does not mean that the student was found responsible for violating the policy.

C. Data from Student Health

Questions related to alcohol, tobacco and other drugs in the Student Health Services Assessment SUNY Survey (SUNY Survey) distributed in 2024, 2022, 2019 and the American College Health Association (ACHA) Survey distributed in 2023 are represented in the chart below. In 2024, 321 students responded to the SUNY Survey compared to 736 in 2022.

- 32% (101 students) do not drink alcohol
- 50 % (159 students) have not had 5 or more drinks in a 2-hour period

• .31% (1 student) consumed 5 or more drinks in a 2-hour period greater than 7 times in the past 2 weeks.

III. Procedure for Distributing Annual Notification to Students and Employees

The Annual Notification of the AOD policy information is distributed through the Clery Report produced by University Police each October and includes standards of conduct, legal sanctions, health risks, drug and alcohol programs and disciplinary sanctions. A mass email to the campus constituencies including faculty, staff and students is sent each October by University Police announcing the release of the Clery report.

V. Summary of AOD Program Strengths and Weaknesses Strengths

 Many departments and individuals at all levels of SUNY Potsdam are involved in work related to AOD prevention and education Student policies consistently enforce standards of behavior related to AOD abuse

Weaknesses

- Work on AOD issues is not done in a formal collaborative manner on our campus as we currently do not have a dedicated health education and prevention staff member
- Students are not aware of the campus' amnesty policy related to drugs and alcohol
- Potsdam does not have data available concerning employee use of alcohol and other substances
- Campus level EAP Coordinator position remains open while a search is underway to fill this position

VI. Recommendation for Revising AOD Program

- With the retirement in summer 2024 of our long-serving campus health educator, there
 is an opportunity to revise the way in which AOD prevention work is managed on
 campus. Establishing an Alcohol and Other Drug Task Force to oversee the work in this
 area would be beneficial.
- Work to strengthen connections between academic experts in health promotion and community health (Department of Public Health and Human Performance) with the providers of prevention programming in Student Affairs, Office of Title IX, Center for Diversity and other offices.
- Explore partnerships with community agencies like Seaway Valley Prevention Council to provide education and outreach to the campus community.

Appendix 1

Excerpts from the Student Code of Conduct, including Greek Life Policies Related to Alcohol and Other Drugs

The Student Code of Conduct contains the following policy statements:

A. Alcohol

Consistent with New York State Law, individuals under the age of 21 years are prohibited from using, possessing, or distributing alcoholic beverages. Individuals over the age of 21 may use and possess alcohol as permitted by the law and College regulations. Open containers and public intoxication are prohibited. Students who are irresponsible in their use of alcohol or who provide alcohol to minors will be subject to this Code regardless of the student's age. This applies to both on campus and off-campus behavior.

B. Drugs

Consistent with the Drug-Free Schools and Communities Act Amendments of 1989 (Public Law 101-226), possessing, using, or distributing a controlled substance or dangerous drug, or any drug unlawful to possess, e.g. cannabis, except as expressly permitted by law is prohibited. Drug paraphernalia including, but not limited to bongs, water pipes, dab rigs, or hypodermic needles that are not specifically required for the administration of prescribed medications are not allowed on campus. Use of legal medication outside the parameters of the medical authorization is prohibited 18 and prescription drugs on campus must have an authentic medical prescription. Students who are irresponsible in their use of cannabis or who provide cannabis to minors will be subject to this Code regardless of the student's age.

C. Smoking/Tobacco

Use SUNY Potsdam is a 100% tobacco free campus. Tobacco use of any kind is prohibited on campus, at extension campuses, at all indoor and outdoor events, and in all vehicles and equipment owned, leased or operated by the college. This includes electronic smoking devices/electronic cigarettes, electronic aerosol delivery systems, and smokeless tobacco. Sale of tobacco products on campus is prohibited. The college will not accept advertising, marketing, distribution, or promotion of tobacco or

electronic cigarette / electronic aerosol delivery device products. (https://www.potsdam.edu/sites/default/files/TobaccoPolicy.pdf).

D. Good Samaritan Policy and Medical Amnesty Policy

At SUNY Potsdam the health and safety of the members of the community is of primary importance and all students are strongly encouraged to be active bystanders who respond in potentially dangerous situations without fear of reprisal from the College. This policy is intended for use in isolated situations and does not excuse or protect those who flagrantly and frequently violate College policy. The purpose of this policy is to increase the likelihood that medical attention is provided to students who need it due to alcohol intoxication or use of drugs by removing impediments to seeking such assistance.

- i. Good Samaritan Policy: The spirit of the Good Samaritan policy is that we all have an ethical responsibility to help people in need. The College expects that students will take an active role in protecting the safety and well-being of their peers and the College community. In order to promote this, when a student assists an individual who is intoxicated or under the influence of drugs in procuring medical assistance, that student may be granted amnesty from formal disciplinary action by the College for violating the alcohol or drug policies. The caller may be required to meet with the Director of Student Conduct or the Campus Health Educator to discuss the incident.
- ii. Medical Amnesty Policy: When a student is intoxicated or under the influence of drugs and seeks medical assistance, they may be granted amnesty from formal disciplinary action by the College for violating the alcohol or drug policies. Upon receiving a report that a student needs medical assistance, College staff will respond through University Police to obtain EMS services, and responding officials will use standard procedures for documenting information and collecting identification of all persons involved. Student Conduct charges will be deferred and will be dismissed upon successful completion of any recommended alcohol and/or drug intervention. Failure to successfully complete the recommended alcohol and/or drug program may result in student conduct action.
- iii. Upon receipt of an incident report/police report, in regard to an alcohol or drug transport, the following will occur:
 - a. The student may be required to obtain an alcohol or drug assessment from the College Health Educator or an off-campus resource. If assessment is

required, a copy of the assessment report will be sent to the Director of Student Conduct.

b. A second transport may not invoke the above Good Samaritan Policy or Medical Amnesty Policy. These policies apply to incidents both on and off campus. These policies do not remove the possibility of other related criminal charges, per state and federal law.

Greek Life Policies Related to Alcohol and Other Drugs

A. The possession, sale, use or consumption of ALCOHOLIC BEVERAGES, while on chapter premises or during a fraternity or sorority event, in any situation sponsored or endorsed by the chapter, or at any event an observer would associate with the fraternity or sorority:

- I. Must be in compliance with any and all applicable laws of the state, province, county, city, and institution of higher education, and
- II. Must comply with either the BYOB or Third-Party Vendor Guidelines.
 - i. Sponsorship and endorsement may include the contribution of funds, supplies, food, or management of the event or significant portion of membership in attendance.
 - ii. There is increased potential for responsibility where alcohol is present at an event.
 - iii. BYOB (Bring Your Own Beverages) is the process where members or guests bring their own individual supply of a beverage for personal consumption. BYOB is not the use of a common source of alcohol provided by any members, alumni, guests, or co-sponsors such as cases of beer, bottles of alcohol, kegs, party balls, etc.
 - iv. Third-Party Vendor use applies to situations in which the organization contracts a licensed purveyor of alcohol in a bar, dance hall, drinking establishment, hotel, restaurant, etc., or by inviting a catering company to the organization's or cosponsor's location.
 - v. The organization may pay for:
 - (1) The vendor employee salaries.

- (2) Set up costs excluding any purchase of alcohol.
- (3) Facility rental.
- vi. Events with a Third-Party Vendor maintain that individuals of age will pay for their own drinks on a cash per drink basis only.
- vii. There may not be "all you can drink" nor "discount" rates by way of chapter subsidy or by gift of the vendor.
- B. No alcoholic beverages may be purchased through or with chapter funds, nor may the purchase of same for members or guests be undertaken or coordinated by any member in the name of or on behalf of the chapter. The purchase or use of a bulk quantity or common source(s) of alcoholic beverage, for example, kegs or cases, is prohibited.
- C. OPEN PARTIES, meaning those with unrestricted access by non-members of the fraternity or sorority, without specific invitation, where alcohol is present, are forbidden.
- D. No members, collectively or individually, shall purchase for, serve to, or sell alcoholic beverages to any minor (i.e., those under legal drinking age).
- E. The possession, sale or use of any ILLEGAL DRUGS or CONTROLLED SUBSTANCES while on chapter premises or during a fraternity/sorority event or at any event that an observer would associate with the fraternity/sorority is strictly prohibited.
- F. No chapter may co-sponsor an event with an alcohol distributor or tavern (tavern defined as an establishment generating more than half of annual gross sales from alcohol) at which alcohol is given away, sold or otherwise provided to those present. This includes any event held in, at or on the property of a tavern as defined above for purposes of fundraising. However, a chapter may rent or use a room or area in a tavern as defined above for a closed event held within the provisions of this policy, including the use of a third-party vendor and guest list. An event at which alcohol is present may be conducted or cosponsored with a charitable organization if the event is held within the provisions of this policy.
 - I. An organization may have events with a bar or drinking establishment, but without the use of advertisement, and only within a controlled setting regarding guests and Third-Party Vendor guidelines.
 - II. The sale of tickets to an event, such as a band, may not be coordinated at the event, may not be used to pay the vendor, and must be paid to the entertainment prior to the event and separate from any situation where alcohol is present. Such events must still remain restricted and careful sale of tickets may only be to those determined by the guest list.

- III. The organization may not advertise for an event using the name of an alcohol vendor or information about the presence of any alcohol whether it is BYOB or using a Third-Party Vendor.
- IV. All financial transactions with the vendor must take place prior to the event and not involve alcohol purchase or subsidy.
- G. No chapter may co-sponsor, co-finance, or attend or participate in a function at which alcohol is purchased by any of the host chapters, groups or organizations.
- H. All recruitment or rush activities associated with any chapter will be non-alcoholic. No recruitment or rush activities associated with any chapter may be held at or in conjunction with a tavern or alcohol distributor as defined in this policy.
- I. No member or pledge, associate/new member, or novice shall permit, tolerate, encourage, or participate in "drinking games."
- J. No alcohol shall be present at any pledge/associate member/new member/novice program, activity or ritual of the chapter. This includes, but is not limited to, activities associated with "bid night," "big brother/big sister night," and initiation.
- K. All Greek organizations must abide by all College documents, policies and procedures, including, but not limited to the New Member Handbook and the Fraternity and Sorority Recognition and Governance statement.



Appendix 2

Drug and Alcohol-Free Workplace Policy

SUNY Potsdam is committed to the development and maintenance of a Drug and Alcohol Free work environment and, in accordance with the Federal Drug Free Workplace Act of 1988 and the State Policy on Alcohol and Controlled Substances in the Workplace, will not tolerate the unlawful possession or use of controlled substances or the on-the-job use or impairment from alcohol in the workplace. Compliance with the provisions of this Policy is a condition of employment with SUNY Potsdam.

SUNY Potsdam employees are subject to the following:

- 1. The term "controlled substance" means a controlled substance in Schedules 1 through V of Section 202 of the Federal Controlled Substance Act (21 USB 812).
- 2. The unlawful manufacture, distribution, dispensation, possession or use of a controlled substance by an employee in all SUNY Potsdam work locations is prohibited. An employee may possess and use a controlled substance which is properly prescribed for him or her by a medical practitioner.
- 3. On-the-job use of or impairment from alcohol by an employee in all SUNY Potsdam work locations is prohibited.
- 4. An employee who unlawfully manufactures, distributes, dispenses, possesses or used controlled substances in the workplace will be subject to disciplinary procedures consistent with applicable laws, rules, regulations, and collective bargaining agreements.
- 5. An employee who uses alcohol on the job or is impaired from the use of alcohol in the performance of the job will be subject to disciplinary procedures consistent with applicable laws, rules, regulations, and collective bargaining agreements.
- 6. An employee convicted of a drug or alcohol related criminal statute violation occurring in or on property owned or controlled by SUNY Potsdam is required to give a signed written notice of the conviction to the Chief of University Police within five (5) calendar days following the conviction.
- 7. SUNY Potsdam will notify the appropriate federal agencies, if applicable, within ten (10) days of receipt of a notice of an employee drug conviction.
- 8. SUNY Potsdam will make every effort to maintain a drug and alcohol free workplace. This effort will include drug and alcohol awareness education, an employee assistance program and the implementation and strict enforcement of this Policy.

Appendix 3 **Campus Alcohol Regulations**

I. Statement of Purpose

SUNY Potsdam recognizes that a responsible attitude towards the use of alcoholic beverages is a desirable goal and should be encouraged by College policy. These regulations are to act as guidelines to provide members of the College community with an opportunity to develop a realistic and reasoned approach to alcohol use. They presume adherence to New York State Law and respect for the rights of all others in the College community. It is important to note that College policy does not recognize misuse of alcoholic beverages as an excuse for misconduct of any kind.

The SUNY Potsdam Alcohol Regulations apply to all members of the College community and their guests. They are in effect for all campus buildings and the College grounds. They are meant to provide a framework through which responsible use of alcohol is a prime objective.

II. State and Local Alcohol Regulations

A. New York State Law

New York State has taken major steps to deal with alcohol abuse. The penalties for ?Driving While Ability Impaired? and ?Driving While Intoxicated? have increased substantially (including fines, suspension or revocation of license, imprisonment.) The best advice: If you drink, don?t drive.

It is a crime in New York State to purchase alcoholic beverages for, or to give alcohol to, a person under 21 years of age. The legislature has passed several bills to substantially increase penalties for these offenses.

Effective December 1985, the minimum legal age for purchase of alcoholic beverages became 21. The College must comply with State law.

Effective October, 1989, a person under the age of 21 who presents an altered New York State driver?s license for the purpose of illegally purchasing an alcoholic beverage may be subject to a suspension of that driver?s license for up to 90 days and may also be required to apply to the Department of Motor Vehicles for a restricted use driver?s license following the suspension.

Effective November 1989, persons under the age of 21 who present falsified or fraudulently altered proofs of age for the purpose of purchasing or attempting to purchase alcoholic beverages are guilty of a violation.

Effective January 1990, persons under the age of 21 are prohibited from possessing any alcoholic beverage with intent to consume the beverage. Alcoholic beverages involved in alleged violations of this law may be seized by authorized law enforcement officials, including University Police.

General Obligations Law of New York State Section 11-100 provides for civil liability against any person knowingly causing intoxication of a person under 21 years of age by furnishing alcoholic beverages to that person or by aiding such a person in procuring alcoholic beverages. Section 11-100 (Dram Act) provides for civil liability against any person selling or procuring alcoholic beverages for an intoxicated person regardless of age.

It is a violation in the Village of Potsdam to possess an open container that contains or has contained alcoholic beverages on a street, in a parking lot, on a highway, on a sidewalk, in other public places or in a motor vehicle. This applies equally to the campus premises.

III. General Regulations

- A. The College will not accept use of alcohol as an excuse for misconduct.
- B. The violation of New York State law and the ordinances of the Village of Potsdam regarding the use and possession of alcohol is a violation of SUNY Potsdam regulations. New York State law regarding DWI and DWAI is applicable to all College property and the violation of same on College property constitutes a violation of these regulations.
- C. Misconduct on College property resulting from the use of alcohol constitutes a violation of these regulations, which may result in penalty as set forth in
- D. Possession of any alcoholic beverage by a person under the age of 21 is expressly forbidden unless as required by that person?s employment responsibilities.
- E. Referrals of alcohol abusers to an appropriate campus program or to the St. Lawrence County Alcohol Referral Service may be a provision of any penalty or sanction for violation of these regulations.
- F. No vendor shall deliver, or cause to have delivered, alcoholic beverages to the campus except where such delivery is made to a licensed vendor (i.e. PACES).
- G. Any violation(s) of these regulations shall be dealt with in accordance with Article VI.
- H. Alcoholic beverage restrictions are determined by the policy governing the type of area in which alcohol is to be involved (i.e. Thatcher Hall, residence hall room) rather than the type of event (i.e. party, function).

IV. Regulation of Alcoholic Functions

A. Campus-wide Regulations

- 1. Reasonable amounts of solid, substantial food and non-alcoholic beverages must be available.
- 2. Availability of alcoholic beverages in PACES leased facilities will be authorized by the Director of Dining Services, or designee, in consultation with the appropriate building administrator. The duration of alcohol service at an event will be determined by the vendor (PACES) as part - 5-1 **Questions?**
- 3. The College reserves the right to charge supervisory fees, cleaning and damage deposits for the use of College facilities. Fees
- 4. Outdoor functions must be approved by the Associate Director of Campus Life.

- 5. The primary thrust of an activity should not be drinking alcoholic beverages. Advertising should promote a realistic activity and advertising will be limited to designated, controlled and appropriate places.
- 6. The number of persons attending a function is limited to the legal limit of the area.
- B. Residence Hall Regulations See the section on Residence Hall Living

V. Application Procedure

Sale and/or Service of Alcohol

The only group that may sell or serve alcohol on the College premises is PACES (by contract with the State University of New York). The only areas licensed for regular sale of alcoholic beverages are the Barrington Student Union and Thatcher Hall and the Student Union Patio. All other areas require that PACES purchase a one-day caterer?s permit from the New York State Liquor Authority. The permit must be visible at the event and no event will be held without this permit. This requires a significant lead time (presently 8 - 10 weeks - please check with the catering office for current information). The cost of this permit will be passed on to the sponsoring group. Failure to receive a permit may require the event to be moved to a licensed facility, if available.

VI. Enforcement Procedures

College groups and individuals not in compliance with this policy may be charged under the College disciplinary system.

VII. Policy Questions or Modifications

Questions or suggestions concerning the sale and/or service of alcohol on campus should be made to the Director of Dining Services. Questions concerning alcohol regulations or suggestions for modification of these policies should be made to the Chief Student Affairs Office or designee.



Appendix 4

Tobacco Free Campus Policy

Definitions

Term	Definition
Tobacco	Any product made or derived from tobacco or which contains nicotine, intended for human consumption, including, but not limited to: cigarettes, cigars, hookah-smoked products, bidis, kreteks, Electronic smoking device/electronic cigarettes, electronic aerosol delivery systems, smokeless tobacco and snus; term also includes herbal cigarettes and nicotine-free electronic smoking devices. Tobacco does not include drugs, devices, or combination products authorized for sale by the state or U.S. Food and Drug Administration, those terms are defined in the Federal Food, Drug and Cosmetic Act.
Component or Part	Any software or assembly of materials intended or reasonably expected: (1) to alter or affect the Tobacco Product's or Electronic Aerosol Delivery System's performance, composition, constituents, or characteristics; or (2) to be used with or for the human consumption of a Tobacco Product or Electronic Aerosol Delivery System. Component or Part excludes anything that is an Accessory, and includes, but is not limited to e-liquids, cartridges, certain batteries, heating coils, programmable software and flavorings for Tobacco Products or Electronic Aerosol Delivery Systems.
Electronic smoking device / electronic cigarette	An electronic smoking device that, when activated, produces an aerosol that may be inhaled. Includes any Component or Part (but not Accessory) and any liquid or other substance to be aerosolized, whether or not separately sold. Includes all electronic smoking devices, regardless of nicotine content level.

Accessory	Any product that is intended or reasonably expected to be used with or for the human consumption of a Tobacco Product or Electronic Aerosol Delivery System; does not contain tobacco and is not made or derived from tobacco; and meets either of the following: (1) is not intended or reasonably expected to affect or alter the performance, composition, constituents, or characteristics of a Tobacco Product or Electronic Aerosol Delivery System; or (2) is intended or reasonably expected to affect or maintain the performance, composition, constituents, or characteristics of a Tobacco Product or Electronic Aerosol Delivery System but (a) solely controls moisture and/or temperature of a stored Tobacco Product or Electronic Aerosol Delivery System; or (b) solely provides an external heat source to initiate but not maintain combustion of a Tobacco Product. Accessory includes, but is not limited to, carrying cases, lanyards and holsters.
College	The State University of New York at Potsdam.
Campus	Any property owned, leased, or operated by SUNY Potsdam, including but not limited to: private offices, dining areas, recreational facilities, residence halls, athletic facilities, all institute owned or operated vehicles, and vehicles used to transport SUNY Potsdam faculty, staff, or students on any institute-related business, academic, or student life activities.
University Organizations	University organizations are institutionalized organizations for students and/or staff that receive funding directly from the University, and which are coordinated or directed by University Staff. Examples include those societies, clubs or the like, which are formed because of the special interest of any particular group of students.
Employee	A public employee working for The College, a Research Foundation employee associated with The College, or a PACES employee associated with The College.
Visitor/Guest	Someone who is not an employee, student, or vendor.
Vendor	A representative that renders goods or services.
Employer	The State University of New York at Potsdam, (The College), Potsdam Auxiliary College Educational Services (PACES).
Supervisor	Any person assigned as a supervisor of record within The College who has the authority to direct and control the work performance of an employee.

Background

In January 1990, the Clean Indoor Air Act (Act) required that stringent regulations governing smoking be implemented in indoor areas open to the public. In passing this law, the State Legislature found that "there is a substantial body of scientific research showing that breathing secondhand smoke is a significant health hazard for nonsmokers." The purpose of this Act is to preserve and improve the health, comfort and environment of the people of this State by limiting exposure to tobacco smoke.

Further, in June 2012, the SUNY Board of Trustees passed a resolution directing all SUNY campuses to begin the work necessary to be tobacco free. As a result, SUNY Potsdam became a tobacco restricted campus. The next step in the process is to become a 100% tobacco free campus.

SUNY Potsdam supports an environment where its students, employees, and visitors do not smoke or use other tobacco products on the campus, and are not exposed to environmental tobacco smoke. SUNY Potsdam cares about the health of all its community members, staff and students and is committed to providing a safe working, living, and educational environment.

Policy Statement

SUNY Potsdam is a 100% tobacco free campus. Tobacco use of any kind is prohibited on campus, at extension campuses, at all indoor and outdoor events, and in all vehicles and equipment owned, leased or operated by the college.

Sale of tobacco products on campus is prohibited. The college will not accept advertising, marketing, distribution, or promotion of tobacco or electronic cigarette / electronic aerosol delivery device products.

Responsibility

Effective implementation of this policy depends on the courtesy, respect, and cooperation of all members of the SUNY Potsdam Community.

Employers and Supervisors (College and vendors) shall communicate this policy to their employees and volunteers.

Event organizers shall communicate this policy to event attendees.

Compliance

Third Party Vendors

- The sale of tobacco products on campus is prohibited.
- The distribution of tobacco products to University organizations is prohibited.
- University organizations are prohibited from accepting money or gifts from tobacco companies, directly or indirectly. This include sponsorship of parties by tobacco companies,

distribution of free, reduced, or full price tobacco products, or any promotional items. This does not apply to research funding.

- Tobacco related advertising or sponsorship is not permitted on or in:
 - College management property, including billboards or signage in stadiums or on campus and at College sponsored events.
 - o Publications produced by the College.
 - Tobacco related advertising is permitted in a newspaper or magazine not provided by the College and which is lawfully sold, bought, or distributed on College managed property; this includes student run newspapers.

This policy is driven by respect for others and the environment and relies on the thoughtfulness, consideration and cooperation of tobacco and electronic cigarette/electronic aerosol delivery users and non-users for its success. Enforcement of this policy will depend on the cooperation of all members of the SUNY Potsdam campus community. The campus community will be treated respectfully in the consistent observance of the policy. It is the responsibility of all members of the College community to observe this tobacco and electronic cigarette/electronic aerosol delivery device use policy.

SUNY Potsdam will inform members of the campus community about the tobacco and electronic cigarette/electronic aerosol delivery device policy by widely disseminating information about the policy. The tobacco free policy will be clearly posted in employee and student handbooks, on the campus website, and included in new employee orientation.

The policy will be shared with parents, alumni and visitors through media, campus announcements, website and other media outlets. Key components of the policy will be posted on signage around campus. Public announcements will address the policy at events on campus.

Non-compliance prompts an educational response, which includes information regarding the existence of the policy, the rationale for the policy and the availability of nicotine cessation support services, both on and off campus.

Excessive non-compliance by students is referred to the appropriate campus student conduct office. If a student is found in violation of this policy, they may be subject to charges as outlined in the Student Code of Conduct.

In the event of non-compliance by Visitors and Guests, University Police may be notified and take appropriate action.

Resources

The College understands the addictive nature of tobacco products, and that breaking the addiction is extremely difficult for many people. The College will make every effort to assist and encourage those who wish to stop using tobacco products and will offer various educational and cessation programs. Employee should contact the Employee Assistance Program (EAP) for more information and assistance. Students and employees should contact the NYS Quitline at 1-800-NY-QUITS.

Policy Review

SUNY Potsdam maintains a broad-based Tobacco Free Taskforce to identify and address concerns related to this policy, the implementation process, compliance, and cessation.
